“SUKANYA” is an initiative of Community Policing Wing, Kolkata Police, a self defence training programme for girl students of School, College & Universities in the city of Kolkata. In this respect applications are invited from willing candidates for temporary engagement as Trainer / Supervisor of Martial Arts. Candidates should preferably be residents within Kolkata Police jurisdiction. Preference will be given to female candidates. Honorarium will be paid based on the number of classes conducted upto a maximum of Rs. 8,000/- per month for Trainers and upto a maximum of Rs. 10,000/- per month for supervisors. The trainers are expected to conduct 48 (Forty Eight) classes of 01 (one) hour duration in a month, covering 02 (two) schools. The supervisors are expected to supervise 04(Four) trainers covering 08(Eight) schools & supervising at least 48 (Forty Eight) Classes in a month. Application should reach the **Project Officer, Sukanya, Community Policing Wing, P -16 Indian Exchange Place Extensions, 7th Floor, KIT Building, Kolkata- 73** within 7 days from date of publication of this advertisement. Applicants are requested to apply as per proforma attached. The filled in application may also be dropped at the box kept for the purpose at Community Policing Wing during office hours on working days.

• **Eligibility criteria of Trainers are given below:-**

1. Age 20-40 years.
2. The applicant must be a citizen of India and should be a permanent resident of West Bengal (the residents of Kolkata will be preferred).
3. Female Trainers will be given preference.
4. Trainers should have sound mental & physical health.
5. Minimum Educational Qualification- X Standard.
6. Professional - Trainers should have obtained a minimum of one level below the Black Belt in the respective Martial art.(Black Belt will be preferred)
7. Having training experience of more than 02(Two) years in Judo / Taekwondo / Kick-Boxing / Wushu / Karate / any other form of Martial Art.
8. Those who successfully performed as trainers in Schools/ Colleges during previous years on Sukanya Project will be given preference.
9. Police clearance certificate is required for every individual trainer.

• **Eligibility of Supervisor are given below:-**

1. Age 25-45 years.
2. The applicant must be a citizen of India and should be a permanent resident of West Bengal (the residents of Kolkata will be preferred).
3. Supervisors should have sound mental & physical health.
4. Minimum Educational Qualification- XII standard.
5. Supervisors should have at least Black Belt 1st Dan or equivalent qualification of respective trade.
6. Having training experience of more than 05(Five) years in Judo / Taekwondo / Kick-Boxing / Wushu / Karate / any other form of Martial Art.
7. Female candidates will be given preference.
8. Those who successfully performed as trainers in Schools/Collages during previous years on Sukanya Project will be given preference.
9. Police Clearance Certificate is required for every individual Supervisor.
